

DECLARATION REGARDING THE ALLERGENICITY OF OENOLOGICAL PRODUCTS MARTIN VIALATTE - STATION OENOTECHNIQUE DE CHAMPAGNE

In conformity with Annex II of the Regulation UE N° 1169/2011, as regard the allergen content, SOFRALAB declares that the following oenological products of MARTIN VIALATTE and STATION OENOTECHNIQUE DE CHAMPAGNE ranges contain ingredients considered allergenic :

Other kinds of allergens as indicated in Annex II of the Regulation UE N° 1169/2011 are not contained in the products marketed by SOFRALAB.
